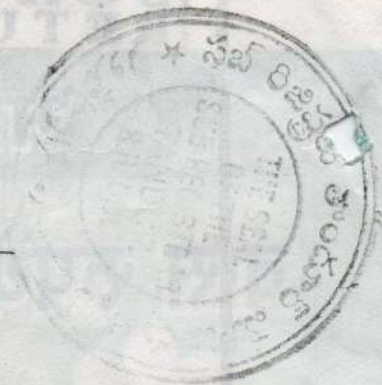

5. POWER.

In pursuance of the foregoing objects (but not further or otherwise) the TRUSTEES are hereby EMPOWERED,

- i. To purchase, take on lease or in exchange, hire or otherwise acquire any property, real or personal, immovable or movable and any rights or privileges necessary for the promotion of the objects of the TRUST and to construct, alter, improve and maintain any buildings or erections or other property necessary for the work of the TRUST.
- ii. To sell all or any, let, mortgage, dispose of or turn to account of the properties or assets of the TRUST,.
- iii. To borrow or raise or secure payment of money in such manner as the TRUST may think fit and to secure the same or the repayment or performance of any debt, liability or contract, guarantee other engagement incurred or to be entered into by the TRUST in any way.
- iv. To permit any agents or any other persons authorized by the TRUST to use and occupy any building, erections or other property of the TRUST on such terms and conditions as the TRUST may deem fit.
- v. To enter into any arrangement with any Government authority, Central, State, Municipal or otherwise in pursuance of the objects of the TRUST and to obtain from any such Government or authority all rights concessions and privileges which may seem conducive to the TRUST'S objects or any of them.
- vi,. To undertake and Execute and take over any Charitable / Religious Trusts/Society/Institutions.
- vii. To receive raise and take any gift or money ' or other property for any of the objects of the TRUST and whether subject to any special trust or not but so that the TRUST may nevertheless decline to accept any gift or take over any property having annexed to it any condition or obligation not approved by the T R U S T .

viii. The funds of the TRUST shall be invested in the modes specified under the provisions of Sec. 13(1) (d) read with section 11 (5) of the Income-tax Act, 1961.

ix. To employ all such officers and servants as may be required for the purpose of the TRUST.

x. To act as agents for any person, body, society or undertaking in any matter and in any lawful manner for the furtherance of the above objects of the TRUST.

xi. To do all such other things as are necessary for the attainment of the above objects or any of them.

xii. The funds and the income of the Trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividends etc.

xiii. The funds/fees/scholarship shall be collected in the name of the trust or its nominees/governing body and shall be accounted to the trust.

xiv. To consider the termination of any trustee/ trustees (except Founder Trustees) who acts against the interest of the Trust and also remove any trustee/trustees without assigning any reasons by majority decision of the Management Trustees.

xv. To lay down general policies for the furtherance of the aims and objects of the trust.

xvi. To appoint committees or sub-committees, patrons, advisory council, general or special purpose for the efficient running of the trust.

xvii. To delegate such of its powers to such trustees as the management trustees of the trust may decide.

xviii. To appoint the trustees to the management trustees who shall have the responsibility for the general administration of the trust.

6. MANAGEMENT

a. The management of the Trust shall vest with the MANAGEMENT TRUSTEES which shall comprise of not more than NINE trustees. The founder Trustees shall be the first Management Trustees who shall be empowered to co-opt Seven more trustees to the Management Trustees. The Management Trustees consist of Founder Trustees and Coopted Trustees

b. The Management Trustees shall have power to constitute/ Appoint Governing Body/Executive Body/ Committee/Sub Committee to run, maintain the activities of the Institutions/ Colleges/Hostel/Churches mentioned in the Aims and objects of the Trust with overall supervision/ Guidance/Control of the Management Trustees.

c. The Management Trustees shall form rules and regulations for each sub-committee/committee/Governing Body and clearly state their duties , power and responsibilities.

7. THE TRUST.

THE TRUST PROPERTY is to be used for the furtherance of the activities as aforementioned and for such other similar activities as majority of the TRUSTEES or their successors shall at any time, determine.

8. THE TRUSTEES:

a. The Managing Trustee: One among the founder trustee shall be the Managing Trustee and shall be appointed from among the Two Founder Trustees within seven days of Registration. First Two Founder Trustees are appointed as Permanent Trustees/Life time Trustees. All other are liable to retire by rotation every two years and they are eligible for reelection.

b. The Hereditary Trustee : Each of the Founder Trustee shall have right to appoint/nominate one trustee each as Hereditary Trustee as successor,. The Hereditary Trustee shall have all the powers and right of the original/founder trustee. Hereditary trustees shall have the same right to nominate/appoint their successors with the same power and right,.

The number of TRUSTEES of the said TRUST shall not at any time be less than two and when there is only One TRUSTEE additional TRUSTEES shall forthwith be appointed PROVIDED nevertheless that the number of TRUSTEES shall not at any time exceed Nine

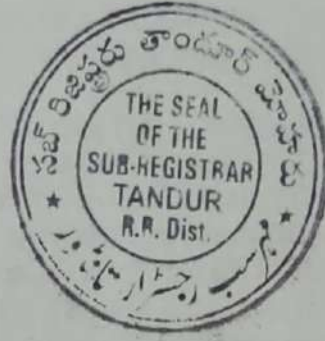
9. ANY of the TRUSTEES may retire from the TRUST hereof by notifying his\her fellow TRUSTEES in writing of his\her intention so to do and from the date of receipt of such notification the retiring TRUSTEE shall be discharged from the TRUST hereof.

10. 11. No person shall be appointed as TRUSTEE who under the preceding clause would be lawfully unable to continue to be a TRUSTEE.

12. PRESIDENT:

He shall be elected by the General Body of the Trustees and shall preside over all the Meetings of the Trust.

13. VICE PRESIDENT:

He Shall be elected by the General Body of the and shall act as the President in the absence President .

14. GENERAL SECRETARY

He shall be elected by the General Body of the Trustees and shall arrange for the proceedings of all the meetings of the trust. He shall arrange for the carrying out of instructions given to such meetings and attend to all statutory requirements imposed on the trust. He shall convene the meetings of the TRUST in consultation with the PRESIDENT.

The GENERAL SECRETARY will have such powers as may be provided in the regulations to be framed from the day to day management of the Trust. The General Secretary shall at all times during the period of office as such devote full attention to the various activities of the trust and employ faithfully and diligently and carry out all necessary steps to ensure the advantage and efficient management of the Trust, The GENERAL SECRETARY shall for services rendered be entitled to draw a monthly salary and other perquisites as may be decided upon by the Trustees from time to time.

15. BANK ACCOUNTS:

Bank accounts of the TRUST shall be opened and operated in the name of the TRUST or any other name as approved by the majority approval of Management Trustees. The Accounts shall be closed with the approval of the majority of Management Trustees.


16. THE ACCOUNT

Account, shall be maintained all accounts of the TRUST regularly. The accounts shall BE audited by a Chartered Accountant every year. Accounts shall be closed every year by 31st of March,

17. MEETINGS OF THE TRUSTEES:

MEETINGS OF THE trustees shall be called by the General Secretary with the consultation with the Management Trustees when the affairs of the TRUST so demand but at least once in every year, such annual meetings being known as the ANNUAL GENERAL MEETING of the TRUST

Seven days' notice shall be given to all TRUSTEES, for all meetings and agenda of the business to be transacted at all meetings shall accompany these respective notices calling such meetings. At every annual General Meeting of the TRUST, the General Secretary shall place before the meeting the report of the activities of the TRUST since the previous Annual General Meeting.

18. A Circular resolution issued by the Managing Trustee in consultation with the President on any subject, and signed by a majority of the Trustees, shall in all respects, be valid and binding as a resolution passed at a meeting of the Trustees duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever.

19. QUORUM & VOTING :One third of the total trustees with the minimum of three office bearers present in the meeting shall form quorum of meeting of Trustees (or) Annual General body. Every Trustee present shall have one vote. Voting by proxy shall not be allowed.

20. DECISIONS OF THE TRUSTEES:

Except where otherwise provided any question arising as to the property or otherwise any transaction of the TRUST shall be conclusively settled as between all parties concerned by decision of majority of the number of MANAGEMENT TRUSTEES for the time being.

21 PRIVILEGES OF TRUSTEES :


a. As per the trust Deed the founder Trustees and other Trustees may be paid actually incurred expenses, remunerations, salary, Honorarium, Pocket expenses, for the work done for the trust.

b. Any trustee of the trust who causes loss, damage etc, to any property of the trust through his/her willful default for neglect shall reimburse to the trust.

23 INDEMNITY:

EVERY TRUSTEE shall be indemnified out of the TRUST FUND against all losses and expenses incurred in the discharge of his duties except such as shall happen through his own negligence willful act or default and each TRUSTEE shall be chargeable with only such money or property as he or they shall actually receive for or in the discharge of the affairs of the TRUST and each shall be answerable only for his own acts, neglects or defaults and not for those for any other person.

24. The trust formed is IRREVOCABLE.


25. VARIATION OF THE TERMS OF TRUST:

ALTERATIONS to the clauses of the Deed shall only be made at a meeting of the TRUSTEES after giving notice of one calendar month which notice shall be accompanied by details of the proposed alterations and shall be subject to confirmation at a second meeting of the Trust held not earlier than one calendar month after the First meeting. Clauses may be altered by the votes of two-thirds of the number of the TRUSTEES with the prior permission of Commissioner of Income-Tax/Director of Income Tax (Exemption). All alterations shall be confirmed by a DEED OF VARIATION OF TRUST,. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of the Section 2(15), 11,m 12, 13, 80G of the Income Tax Act 1961.

26) DISSOLUTION AND DISTRIBUTION OF ASSETS:



Solar Water Heating System

Solar water heating system is a device that helps in heating water by using the energy from the SUN. This energy is totally free. Solar energy (sun rays) is used for heating water. Water is easily heated to a temperature of 60-80o C. Solar water heaters (SWHs) of 100-300 liters capacity are suited for domestic use. Larger systems can be used in restaurants, canteens, guest houses, hotels, hospitals etc. A 100 liters capacity SWH can replace an electric geyser for residential use and may save approximately 1500 units of electricity annually. The use of 1000 SWHs of 100 liters capacity each can contribute to a peak load saving of approximately 1 MW. A SWH of 100 liters capacity can prevent emission of 1.5 tones of carbon dioxide per year.

Working Of a Solar Water Heater

The Sun's rays fall on the collector panel (a component of solar water heating system). A black absorbing surface (absorber) inside the collectors absorbs solar radiation and transfers the heat energy to water flowing through it. Heated water is collected in a tank which is insulated to prevent heat loss. Circulation of water from the tank through the collectors and back to the tank continues automatically due to thermo siphon system. Based on the collector system, solar water heaters can be of two types: A solar water heater consists of a collector to collect solar energy and an insulated storage tank to store hot water. The stored hot water can be used later any time.

Main Components Of Solar Water Heating System

Main components of solar water heater system are

- Solar Collector(to collect solar energy)
- Insulated tank (to store hot water)
- Supporting stand
- Connecting pipes and instrumentation etc.
